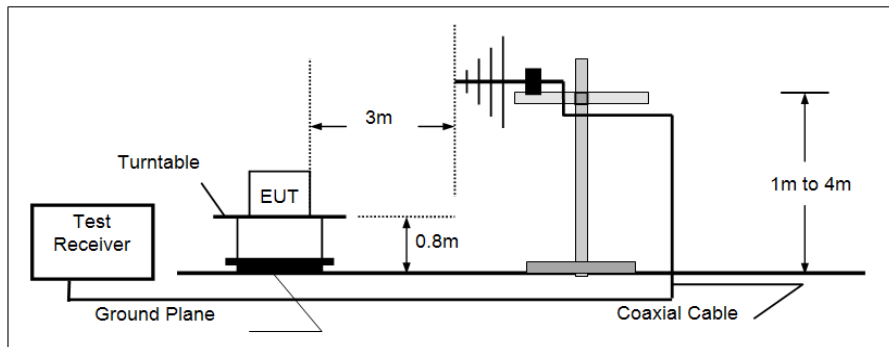

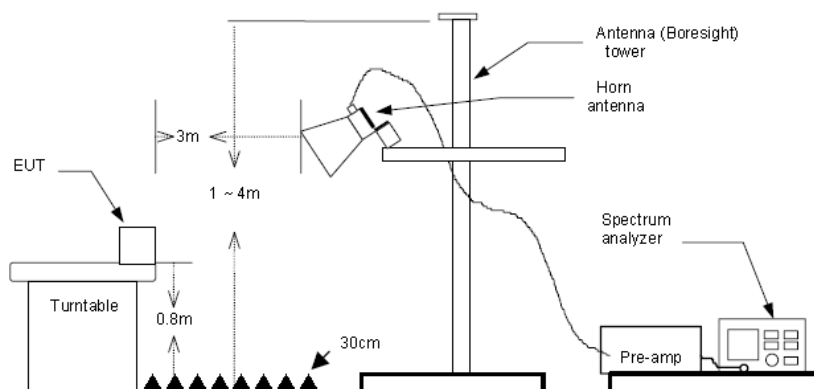

TEST PROCEDURE

- The EUT was tested according to ANSI C63.4:2014.
- The EUT is placed on a turn table which is 0.8 meter above ground.
- The turn table is rotated 360 degrees to determine the position of the maximum emission level.
- The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
- The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna.
- Use the following spectrum analyzer settings
 - Span shall wide enough to fully capture the emission being measured;
 - Below 1GHz,
RBW=120KHz, VBW=300KHz, Sweep=auto, Detector function=peak, Trace=max hold;
If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using

the quasi-peak detector and reported.
(3) From 1GHz to 5th harmonic, RBW=1MHz, VBW=3MHz

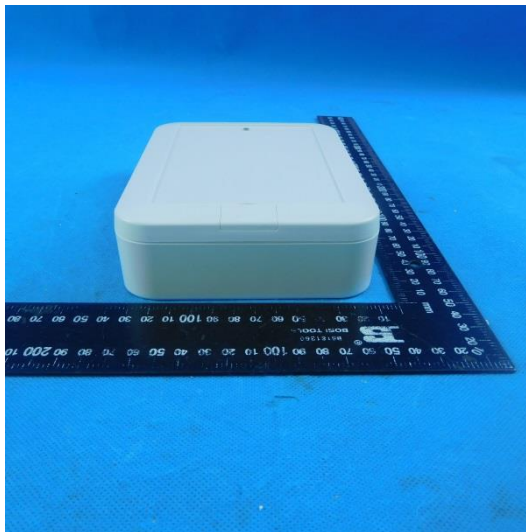
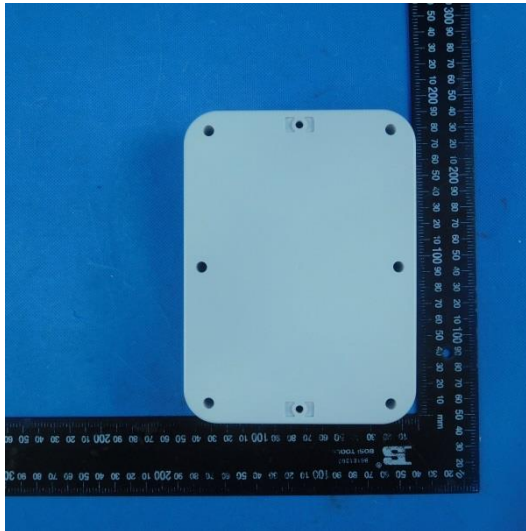
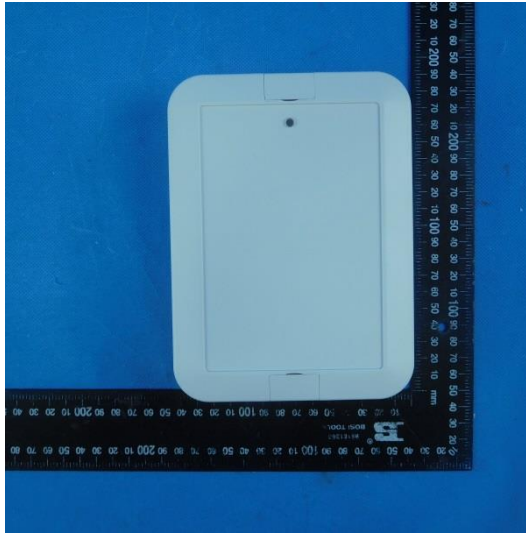


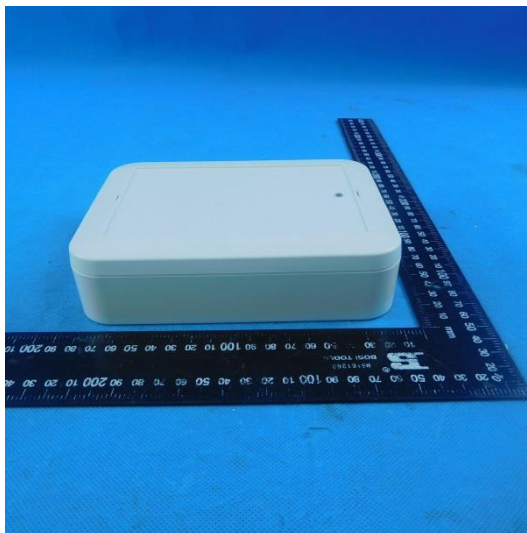
Radiated Emissions (Above 1GHz)



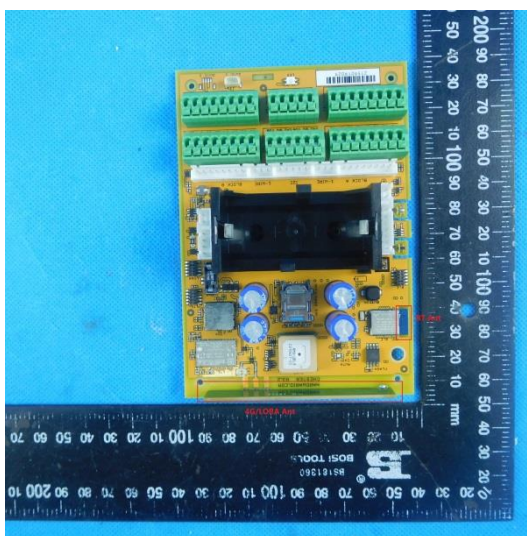
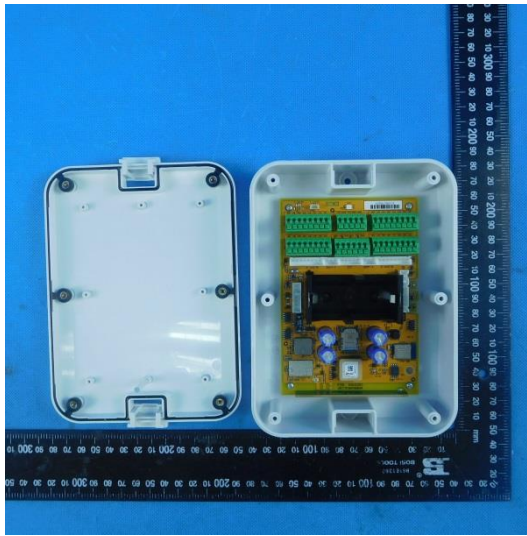
